4. FIRST AID MEASURES

Eye Contact Rinse eyes cautiously with water for several minutes. Remove any contact lenses if easy to do, and continue rinsing. If discomfort or irritation persists contact a physician.

5. FIRE FIGHTING MEASURES

Suitable extinguishing media
