All Cadet Parts

LIMITED 90-DAY WARRANTY: Cadet will repair or replace any Cadet part found to be defective within 90 days from the date of purchase. This warranty only applies to parts purchased or installed after the expiration of any other applicable warranty period.

Extended Product Warranties

Electronic Wall Thermostats

LIMITED ONE-YEAR WARRANTY: Cadet will repair or replace any electronic wall thermostat found to be defective or malfunctioning within one year after the date of purchase.
