(b) Special hazards arising from the chemical

(c) Special protective equipment and precautions for fire-fighters

6. Accidental release measures

If battery casing is dismantled, small amounts of electrolyte may leak. Collect all released material in a plastic lined container. Dispose off according to the local law and rules. Avoid leached substances to get into the earth, canalization or waters.

7. Handling and storage

(a) Precautions for safe handling

For devices to be used by children, the battery casing should be protected against unauthorized access. Unpacked batteries shall not lie about in bulk. In case of battery change always replace all batteries by new ones of identical type and brand. Do not swallow batteries. Do not throw batteries into fire. Avoid deep discharge. Do not short-circuit batteries Use recommended charging time and current.

If the Polymer Lithium Battery is subject to storage for such a long term as more than 3 months, it is recommended to recharge the Polymer Lithium Battery periodically. Operating temperature: Charge: $0^{\circ}C \sim 45^{\circ}C$. Discharge: $-20^{\circ}C \sim 60^{\circ}C$ And recommended at $-20^{\circ}C \sim 45^{\circ}C$ for 1 month storage, at $-20^{\circ}C \sim 35^{\circ}C$ for 3 months storage. The capacity recovery rate in the delivery state (50% capacity of fully charged) after storage is assumed to be 80% or more. The voltage for a long time storage shall be $3.7V\sim 4.2V$ range. Do not storage Polymer Lithium Battery haphazardly in a box or drawer where they may short-circuit each other or be short-circuited by other metal objects. Keep out of reach of children.
