Limited Lifetime Warranty for Mr.Steam® Residential Steambath Generators

Mr.Steam® warrants that every Mr.Steam Residential Steambath Generator ("Generator") will be free from defects in materials and workmanship for its lifetime. Mr.Steam will repair or replace (at its option) a Generator which fails to conform to this warranty.

Warranty Service within 2 years from date of purchase

If the warranty claim is made within two years from the date of purchase of the Generator, Mr.Steam will provide free in-home warranty service, parts and labor.

Warranty Service after 2 years from date of purchase

If the warranty claims is made after two years from the date of purchase of the Generator, Mr.Steam will provide a lifetime warranty on parts.

To return a Generator to Mr.Steam, a Return Authorization Number (RMA) must be issued. An RMA and other required information must be written on the return packaging as instructed by Mr.Steam.

If Mr.Steam issues an RMA, Mr.Steam will pay the freight charges to ship the Generator to Mr.Steam and for Mr.Steam to return a repaired or replacement Generator.

Note:

If in the judgment of Mr.Steam the defect is not covered by this warranty, the costs of any in-home service as well as the costs of repair or replacement together with all freight charges will be the responsibility of the claimant.
