

Do not assemble on flooring or carpet-




Assemble on a clean non-marring surface (packing foam)-




Save all packaging until finished-

Assembly Steps



This Rocking Chair has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Rocking Chair, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.





Open the carton and place all the parts onto a clean, non-marring surface.

Attach Cross Bar(C) to Left Leg with Arm(A) using Bolts(1) and Washers(4) with Allen Key(5).


Do not fully tighten the Bolts.

Note: The Front and Back of the Cross Bars are Labelled. Be sure to check the stickers before attaching the parts.

It is recommended that you have a partner to assist during the entire assembly process.

Repeat this process with the Right Leg with Arm(B) and remaining Cross Bar.


Step 2



Attach Seat Panel(E) to Left Leg with Arm(A) using Bolts(②) and Washers(④) with Allen Key(⑤).


Do not fully tighten the Bolts.

Step 3



Attach Seat Panel(E) to Right Leg with Arm(B) using Bolts(②) and Washers(④) with Allen Key(⑤).


Do not fully tighten the Bolts.



Attach Backrest Panel(D) between Left Leg with Arm(A) and Right Leg with Arm(B) using Bolts(3) and Washers(4) with Allen Key(5).

Now, fully tighten all Bolts at all joints in a sequential manner.





Place the Cushion(F) on the Seat.

Your Rocking Chair is ready for use.

This Rocking Chair can only be used on a flat, level suface.

Note: Children should be supervised at all times when using the Rocking Chair.

Care & Maintenance

Do not put hot items directly on furniture surface

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
