2. Hazard Identification

EMERGENCY OVERVIEW: Harmful if swallowed. Causes eye irritation. Vapors irritating to eyes and respiratory tract. Combustible liquid and vapor. Harmful if inhaled. May affect the brain or nervous system causing dizziness, headache or nausea.

4. First-aid Measures

6. Accidental Release Measures

7. Handling and Storage

8. Exposure Controls/Personal Protection

ENGINEERING CONTROLS: Use process enclosures, local exhaust ventilation, or other engineering controls to control airborne levels below recommended exposure limits. Prevent build-up of vapors by opening all doors and windows to achieve cross-ventilation.
