

10 YEAR LIMITED WARRANTY COVERAGE

The manufacturer warrants that the products ("Products") you purchased will be free from defects in material and workmanship for a period of ten (10) years from the date of purchase when used for single-family residential use. This limited warranty extends only to the original end user of the Products, and is not transferable.

ONE YEAR LIMITED NON-RESIDENTIAL WARRANTY COVERAGE

The manufacturer warrants that the products ("Products") you purchased will be free from defects in material and workmanship for a period of one (1) year from the date of purchase when used for non-residential or commercial use. This limited warranty extends only to the original end user of the Products, and is not transferable.

EXCLUSIVE REMEDY

If any components of the Products you purchased are defective in material and workmanship, the manufacturer will repair the component(s) or, in its sole discretion, replace the component(s) with a like or substitute component. This is your sole and exclusive remedy for any defect in the Products.
