## **Sink Warranty**

Ticor extends this warranty to the original purchaser for personal household use of the Sink ("Product") in its original installation location. The warranty is non-transferable.

The warranty commences from the initial date of purchase by the owner or trade professional, from an authorized Ticor dealer, through the lifetime of the Product. Any Product found defective within the warranty period will be repaired, replaced with a Product of equal value, or remedied with a monetary reimbursement not to exceed the original purchase price, at the option of Ticor. Remedy will be provided within thirty (30) days of notice of a covered defect. This warranty extends to the original owner or end-user, and is not transferable to a subsequent owner.
