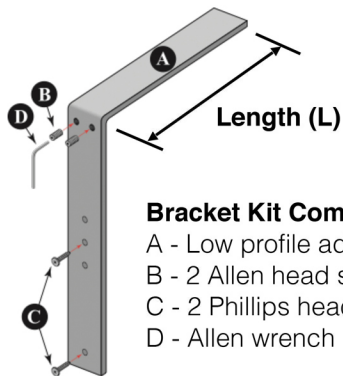

Low Profile Adjustable Bracket Installation Kit and Requirements



Bracket Kit Comes:

- A - Low profile adjustable bracket
- B - 2 Allen head set screws
- C - 2 Phillips head wood screws
- D - Allen wrench

Bracket Installation Requirements:

- Wall thickness between 3/4" - 4" (add material if < 3/4")
- Must be placed directly under any seams in countertop
- Used for overhangs between 8" and 18"

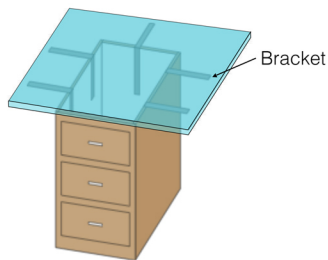
Tools Needed:

- Phillips screw driver
- 1/8" drill, caulk
- Router
- Wood chisel

Bracket Mounting Options

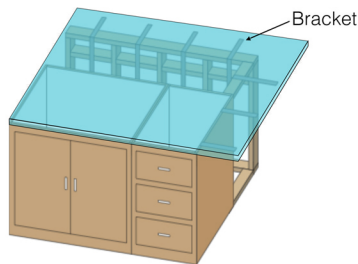
Option 1: Mount to Cabinet

(Wall Thickness usually 3/4" to 2")



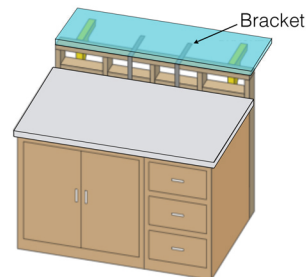
Option 2: Single Level, Wall Mount

(Wall thickness usually 4")



Option 3: Two Level, Wall Mount

(Wall usually 4", requires locking wedge)



Select Bracket Length (L) Based Upon Wall Thickness and Overhang

3 Steps to Determine Bracket Length Needed:

- (1) Select wall thickness (3/4", 2", 3", 4")
- (2) Select desired overhang (8 in. to 18 in.)
- (3) Color in Table corresponds to bracket Length (L)

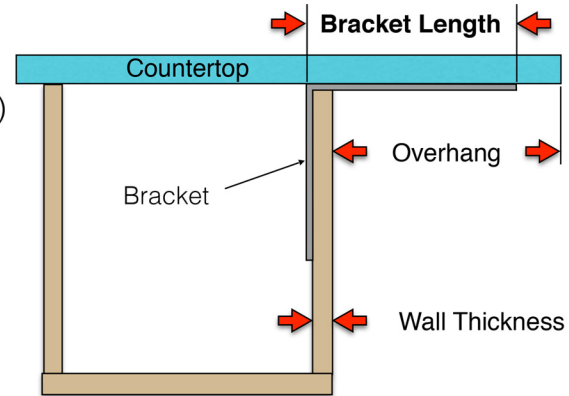

Determine Number of Brackets Required & Spacing

3 Steps to Determine # Brackets and Spacing:

- (1) Select countertop design (one level or two level)
- (2) Use Table below to find # brackets needed





Width (W)	# Brackets (One Level)	# Brackets (Two Level)
24 to 28	2	2 w/ wedge*
29 to 48	3	3 w/ wedge*
49 to 68	4	4 w/ wedge*
69 to 88	5	5 w/ wedge*
89 to 108	6	6 w/ wedge*

* Wedge 1-2" Wide, sharp to 1/16" thick

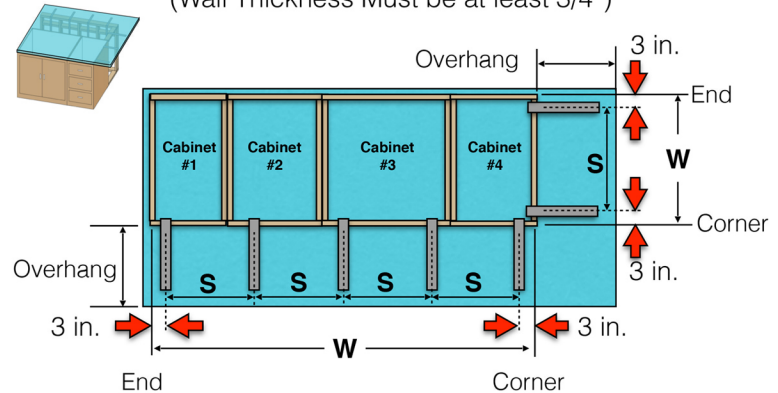
- (3) Calculate spacing (S) using equation below

$$S = \frac{(W-6)}{(\# \text{ Brackets})-1}$$

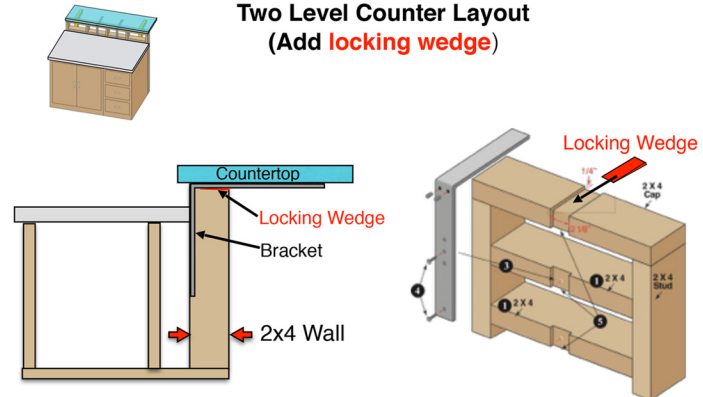

One Level Counter Layout (Wall Thickness Must be at least 3/4")



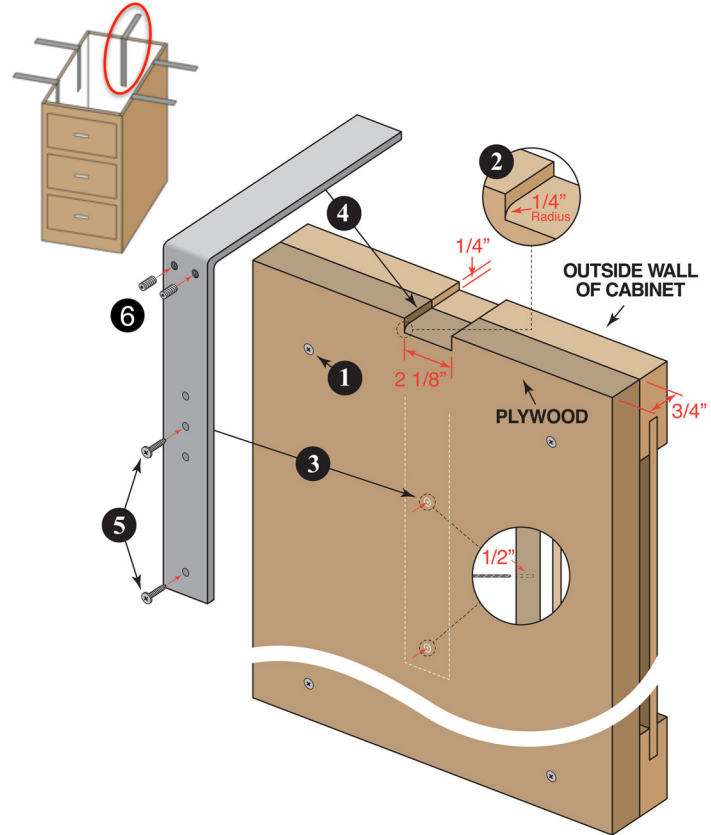
Two Level Counter Layout (Add locking wedge)



Option 1A: Mounting Bracket to Back of Cabinet

Reference the numbers below with the diagrams

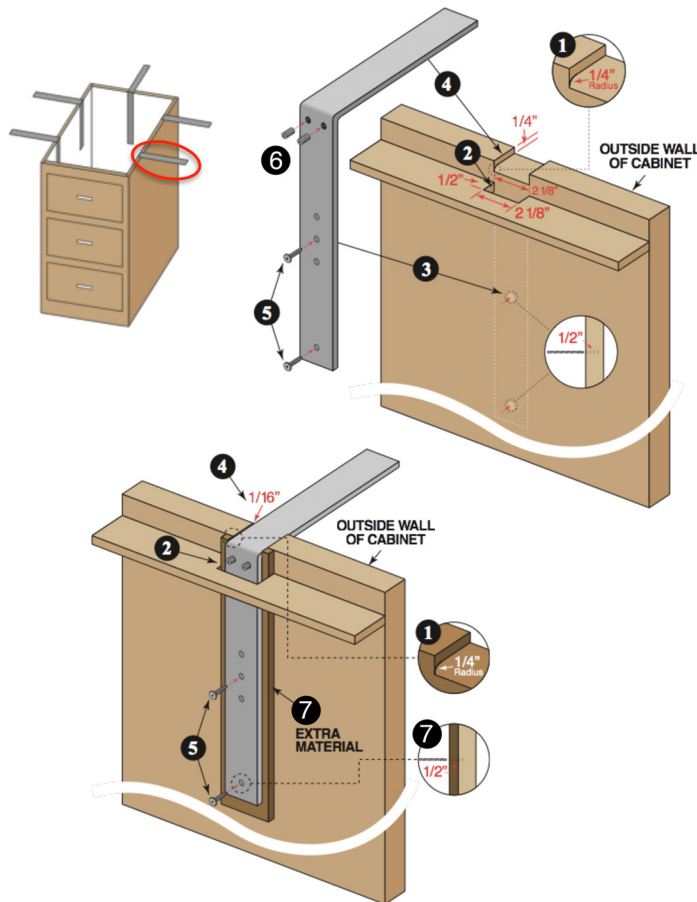
1. Attach 3/4" plywood (if necessary) to inside of cabinet to meet 3/4" min wall thickness requirement. Attach using 4 wood screws (not included).
2. Notch top wall 1/4" by 2 1/8". Cut 1/4" radius on inside wall
3. Using bracket as a template, mark holes and drill 1/8" pilot holes 1/2" deep
4. Make sure bracket fits tightly on wall surface and there is **1/16" gap (very important)** from top of bracket to top of wall. If not, remove material in notch or radius.
5. Attach bracket to wall using 2 - 3/4" wood screws, one in bottom hole and one in middle hole.
6. Go to page "Adjusting Set Screws and Installing Countertop"



Option 1B: Mounting Bracket to Side of Cabinet

Reference the numbers below with the diagram

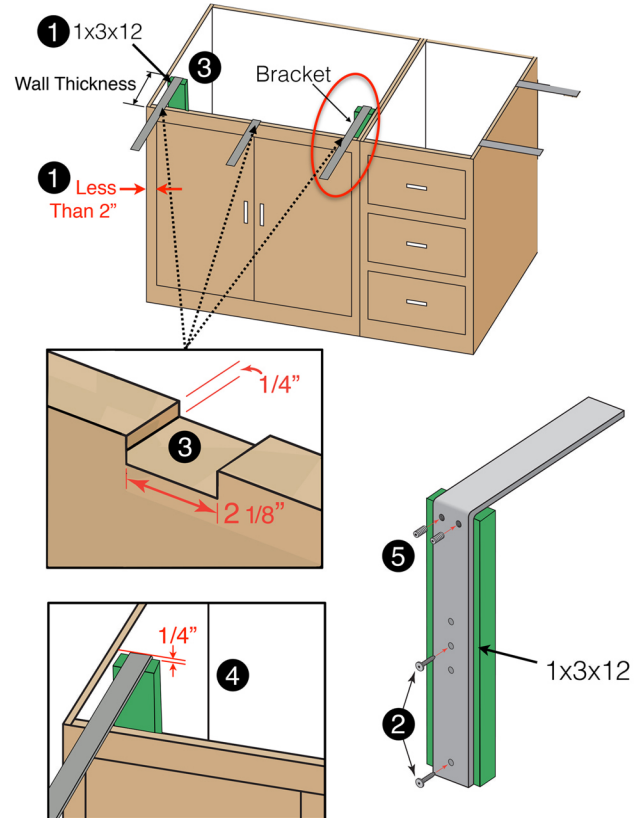
1. If wall thickness is at least $\frac{3}{4}$ " notch top of wall $\frac{1}{4}$ " by $2\frac{1}{8}$ ". Cut radius on inside wall. If wall is less than $\frac{3}{4}$ ", add material to inside of wall so wall is at least $\frac{3}{4}$ ". (see number 7 in lower image)
2. Using a jigsaw, cut a slot at least $\frac{1}{2}$ " by $2\frac{1}{8}$ " in any support that obstructs the bracket's fit.
3. Using bracket as a template, mark holes and drill $\frac{1}{8}$ " pilot holes $\frac{1}{2}$ " deep at two places.
4. Make sure bracket fits tightly on wall surface and there is **$\frac{1}{16}$ " gap (very important)** from top of bracket to top of wall. If not, remove material in notch or radius.
5. Attach bracket to wall using 2 - $\frac{3}{4}$ " wood screws, one in bottom hole and one in middle hole.
6. Go to page "Adjusting Set Screws and Installing Countertop"



Option 1C: Mounting Bracket to Front of Cabinet with Doors

Reference the numbers below with the diagrams

1. If there is not a 2" wide surface to mount bracket on front wall, a 1x3x12 piece of wood can be mounted to the cabinet sidewall several inches away from the front face. The distance from the front face to the back side of 1x3x12 becomes the wall thickness when sizing the bracket.
2. Attach each bracket to a 1x3x12 piece of wood using 2 wood screws provided.
3. Fit-check the bracket on sidewall and mark the top wall of front cabinet where each bracket is located. Notch top $\frac{1}{4}$ " by $2\frac{1}{8}$ " at each location.
4. Attach 1x3x12 to sides of cabinet using 3 wood screws (not provided), making sure that there is **$\frac{1}{4}$ " gap (very important)** from the top of 1x3x12 to the top of wall. If not, adjust 1x3x12 up or down to set gap.
5. Go to page "Adjusting Set Screws and Installing Countertop"

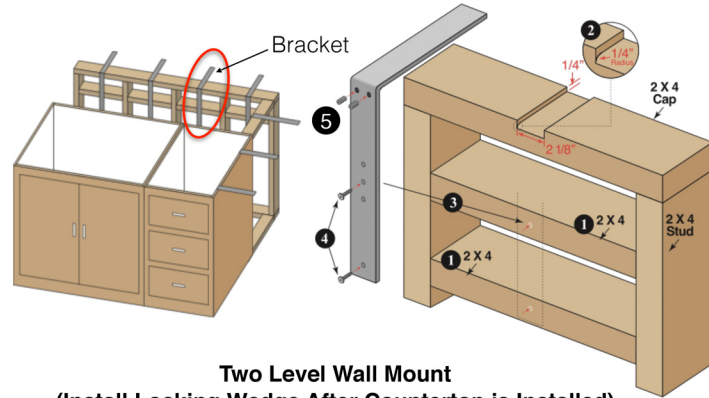


Option 2 and 3: Mounting Bracket to Wall

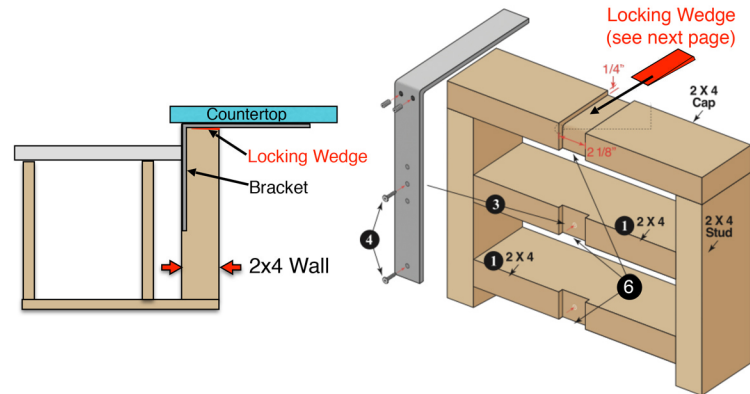
Reference the numbers below with diagrams

1. Install 2x4 cross braces between wall studs to support bracket. The bracket can be mounted on stud or any location on cross braces. Use bracket as template to locate cross braces.
2. If single level countertop, notch top of 2x4 cap $\frac{1}{4}$ " by $2\frac{1}{8}$ ". Cut $\frac{1}{4}$ " radius on inside wall. If two level, make additional notches on back of wall $\frac{1}{2}$ " deep by $2\frac{1}{8}$ " so backsplash or finished surface can cover bracket. (see number 6 in lower image)
3. Make sure bracket fits tightly on wall surface and there is **$\frac{1}{16}$ " gap (very important)** from top of bracket to top of wall. If not, remove material in notch until bracket is $\frac{1}{16}$ " from top surface of wall.
4. Attach bracket to wall using 2 - $\frac{3}{4}$ " wood screws, one in bottom hole and one in middle hole.
5. Go to page "Adjusting Set Screws and Installing Countertop"

Two Level Wall Mount (Install Locking Wedge After Countertop is Installed)



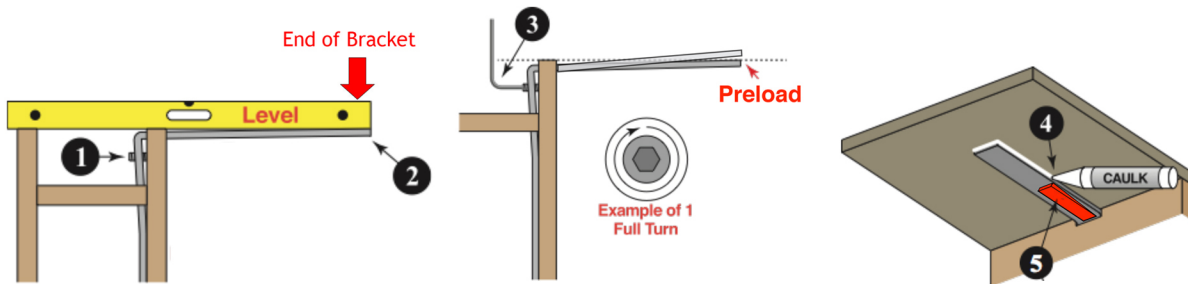
Adjusting Set Screws and Installing Countertop

Reference the numbers below with the diagrams

1. Turn set screws to level end of bracket with other parts of counter.
2. Use a level to confirm end of bracket is level and both set screws are equally engaged.
3. Turn both set screws additional turns based upon Table 2. This provides support at the end of the bracket and ensures uniform support of your specific countertop by preloading bracket.
4. Install countertop and apply caulk around perimeter of bracket under countertop.
5. Install locking wedge (**only for two level countertop**) and make sure countertop is level. Make small adjustment to set screws if necessary.
