Before beginning assembly, make sure all parts are present. Compare parts received with the "Parts List." If any part is missing or damaged, do NOT attempt to assemble the product. GENERAL INFORMATION

Your new chair and ottoman set are made from the finest materials available. It should provide many years of enjoyment with minimal care.

Keep your chair and ottoman set clean. For best results, clean with a soft, damp cloth. If you use furniture covers, always make sure the chair and ottoman set are clean and completely dry before covering, as mold may form in dark, wet places. Remove cushions prior to covering and store them in a dry, temperature controlled place. Check the connectors on your chair and ottoman set regularly to make sure they are secure.

The weight limit for one seat of the chair is 250 lbs.



SAFETY INFORMATION

WARNING

DO NOT stand or allow children to stand on the assembled product. Make sure connectors are securely in place. Perform periodic checks to make sure the connectors are secure and adjust if needed.

CAUTION

READ all instructions before beginning assembly. Failure to do so may result in faulty assembly and potential injury. Assemble the item on a soft, non-abrasive surface such as carpet or cardboard to avoid damaging the item.


SUGGESTIONS




ASSEMBLY



Attach Chair Seat (A) to Chair Back (B) using 2 - M6x40 Bolts (D) and Washers (D). Tighten with Allen Wrench (M).




Hardware Used: M6x40 Bolt x 2 Washer x 2



Attach Right and Left Arms (&) to assembled Seat/Back using M6x20 Bolts (and Washers () and M6x40 Bolts () and Washers (). Tighten with Allen Wrench ().



Hardware Used: M6x40 Bolt x 2 M6x20 Bolt x 6 Washer x 8




ASSEMBLY




Attach the Bar () to the assembled chair using M6x20 Bolt () and Washers () on each side. Tighten with Allen Wrench ().



Hardware Used: M6x20 Bolt x 4 Washer x 4



Turn the assembled chair upright and rest
on a flat, level surface. Place the Lumbar
Cushion () in the chair and enjoy you new seating!


5 Attach **Front Leg** and **Back Leg** to **Ottoman Top (b)**. Slide **M6x35 Bolt** through **Washer (c)** and then into **Spacer (c)**. Slide Bolt through hole in **Ottoman Top** and **Leg** and secure with **Washer (c)** and **Nut (c)**. Tighten with **Wrench (c)** and **Allen Wrench (d)**.
