#### **WHAT IS COVERED?**

Neoperl warrants to the original consumer purchaser that this faucet aerator, spray, laminar device, or faucet or shower adapter/fitting, will be free from defects in design, material, and manufacturing workmanship under normal installation, use, and service. Where Neoperl inspection discloses any such defects within the Warranty Period, Neoperl will replace above mentioned products **FREE OF CHARGE**. This warranty applies only to faucet aerators, sprays, laminar devices, or faucet or shower adapter/fittings, purchased and used by the original consumer purchaser in the United States, Canada or Mexico.

#### **HOW LONG DOES THE WARRANTY COVERAGE LAST?**

This limited warranty remains in force for one (1) year from date of purchase (the "Warranty Period").
