2. Hazard Identification

EMERGENCY OVERVIEW: Harmful if inhaled. May cause delayed lung damage.

EFFECTS OF OVEREXPOSURE - EYE CONTACT: Irritating, and may injure eye tissue if not removed promptly.

EFFECTS OF OVEREXPOSURE - SKIN CONTACT: Low hazard for usual industrial handling or commercial handling by trained personnel.

4. First-aid Measures
