

# 90 DAY Limited Warranty

For 90 Days from date of purchase, Nordic Auto Plow LLC warrants against the defects due to workmanship or materials to the original purchaser. Nordic Auto Plow LLC obligations under this warranty are limited to the following guidelines:

- This warranty does not cover units that have been altered / modified or damaged due to: normal wear, improper maintenance, and / or improper use. It is intended solely for the use of personal driveways and is not to be used for commercial purposes or public streets. Use of this product in a commercial setting voids this limited warranty.
- This warranty does not cover surface scratches to the plow, which is considered normal wear.
- This warranty does not cover any damage which may occur as a result of the misuse of the equipment.
- This warranty extends to the original purchaser only and is not transferable or assignable to subsequent purchasers.
