Nipple Warranty Certificate Ready-cut

MUELLER INDUSTRIES, INC.

BLACK AND GALVANIZED CUT PIPES (FROM 18" TO 120")

This warranty is provided by Mueller Industries, Inc. (collectively, "Mueller") to purchasers ("Purchasers") of black and galvanized cut pipes manufactured by Mueller (the "Products").

Cut pipes manufactured by Mueller are made according to the following specifications:

- ASTM A53, Standard Specification for Pipe, Steel, Black and Hot Dipped, Zinc-Coated, Welded and Seamless.
- ASTM A733, Standard Specification for Pipe, Welded and Seamless Galvanized Carbon Steel and Austenitic Stainless Steel.
- ANSI/ASME B1.20.1, Standard Specification for threading.

Mueller warrants that for a period of twenty (20) years from date of delivery, the Products, when properly installed (out of corrosive environment, inside and outside the pipe) will be free from defects in design and workmanship under normal conditions of use.

As long as (i) such failure occurs within twenty (20) years from the date the warranty begins and (ii) the Purchaser notifies Mueller of each failure, in writing, Mueller will correct the failure by replacing or providing a credit for the Product within a reasonable time, without charge.

This warranty does not extend to:

- 1) Products used for purposes other than intended as defined by local plumbing and building codes, and the applicable ASTM standard.
- 2) Products not installed in a good and workmanlike manner consistent with normal industry standards; not installed in accordance with good plumbing practices; or not installed in conformance with all local plumbing, fire and building code requirements.
- 3) Products that fail due to defects or deficiencies in design, engineering, or installation of the piping system of which they are a part.
- 4) Products that have been subjected to modification; misuse; misapplication, improper maintenance or repair; damage caused by the failure or negligence of anyone other than Mueller; or any other act or event beyond the control of Mueller.
- 5) Products that fail due to the freezing of water in the Products.

MUELLER EXPRESSLY DISCLAIMS ANY LIABILITY FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES. THIS IS THE ONLY WARRANTY PROVIDED BY MUELLER TO PURCHASER AND IS IN LIEU OF ANY AND ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO AN IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR PARTICULAR PURPOSE.
