- Spill** :

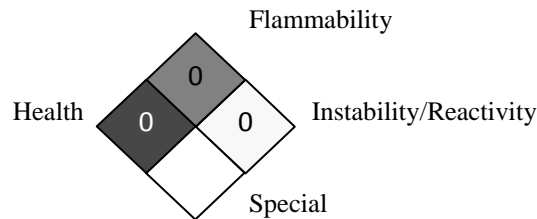
