


Open the carton, and place all parts on a clean, non-marring surface.

Place the Left Armrest(C) face down.

With the assistance of your adult partner, turn the Seat(A) over and place onto the Left Armrest(C).

Attach the Seat(A) to the Left Armrest(C) using Bolts(②) and Washers(①) with Allen Key(③). **Do not fully tighten the Bolts.** 




Place the Right Armrest(B) face down.

With the assistance of your adult partner, turn the Seat(A) and Left Armrest(C) over and place onto the Right Armrest(B).

Attach the Seat(A) to the Right Armrest(C) using Bolts(②) and Washers(①) with Allen Key(③).

Do not fully tighten the Bolts.



With the help of your adult partner, stand the Loveseat up.

Place the Loveseat on a LEVEL SURFACE.

Inspect it and make sure all parts are adequately connected.

Gently and gracefully, sit into to the Loveseat

Then get off the Loveseat, and in a sequential manner, proceed to tighten all Bolts.


When tightening the Bolts, tighten sequentially.

DO NOT tighten any Bolt fully and then move on to the next one.


This may cause the frame to warp.

If there are still wobbles, loosen the Bolts and execute this same process.

If the Loveseat is not stable it could lead to damage to the product.




With the assistance of your adult partner, turn the Loveseat over and place the Bolt Caps(④) on all Bolts.




Stand the Loveseat upright.






Place the Right Armrest(B) face down.

Do not fully tighten the Bolts.



With the help of your adult partner, stand the Chair up.

Place the Chair on a LEVEL SURFACE.

Inspect it and make sure all parts are adequately connected.

Gently and gracefully, sit into to the Chair

Then get off the Chair, and in a sequential manner, proceed to tighten all Bolts.


When tightening the Bolts, tighten sequentially.

DO NOT tighten any Bolt fully and then move on to the next one.

This may cause the frame to warp.


If there are still wobbles, loosen the Bolts and execute this same process.

With the assistance of your adult partner, turn the Chair over and place the Bolt Caps(4) on all Bolts.


## Step 5

Place one Leg(H) over onto the Table Top(G).


Attach the Leg(H) to the Table Top(G) using Bolts(②) and Washers(①) with Allen Key(③).

Tighten Bolts in a sequential manner.


