





# Assembly Steps





This Armless Chair has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Armless Chair parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.





Step 4
Turn the Chair over, and attach Bolt(⑤) and Washer(③) using Allen Key(④) as pictured above. Only loosely tighten Bolts. Step 5
Turn the Chair right side up. Place the Chair on a LEVEL SURFACE. Inspect it and make sure all parts are adequately connected. Gently and gracefully, sit into to the Chair. This would help to align all the parts at all the joint areas. Then get off the Chair, and in a sequential manner, proceed to tighten all bolts.
When tightening the Bolts, tighten sequentially. DO NOT tighten any Bolt fully and then move on to the next one. This may cause the frame to warp. If there is still wobbles, loosen the bolts and execute this same process. If the Chair is not stable it could lead to damage to the product. Note: This step is done better with the assistance of a second adult.
