## 4. First-Aid Measures

## 6. Accidental Release Measures

## 8. Exposure Controls / Personal Protection

#### PERSONAL PROTECTION

**ENGINEERING CONTROLS:** Use explosion-proof ventilation equipment. ## 10. Stability and Reactivity

**CONDITIONS TO AVOID:** Avoid temperatures above 120°F (49°C). Avoid all possible sources of ignition. **INCOMPATIBILITY:** Incompatible with strong oxidizing agents, strong acids and strong alkalies.

## 11. Toxicological Information

**EFFECTS OF OVEREXPOSURE - INHALATION:** High gas, vapor, mist or dust concentrations may be harmful if inhaled. High vapor concentrations are irritating to the eyes, nose, throat and lungs.
