## 2. Hazards identification

**Emergency overview**

## 6. Accidental release measures

**Environmental precautions**

Large spill

# 7. Handling and storage

**Handling** 

: Materials such as cleaning rags, paper wipes and protective clothing, which are contaminated with the product may spontaneously self-ignite.
