Attach Right Leg(A) and Left Leg(B) to Seat(F) using Bolts(1) and Washers(2) with Allen Key(3) as shown in the picture above. Each leg need 4pcs bolts, totally 2pcs leg (A) and (B), 8pcs bolts as the pictures be circled.

Tighten the Bolts fully in a sequential manner.



Tighten the Bolts fully in a sequential manner.






Then, with the assistance from an adult partner, stand the Table upright. Adjust the Pre-installed Levellers until the Table is level with the ground.
