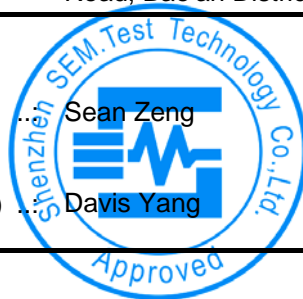

And recommended at 0°C~+35°C for long period storage.

The capacity recovery rate in the delivery state (50% capacity of fully charged) after storage is assumed to be 80% or more.

The voltage for a long time storage shall be 3.0V~4.2V range.

Do not storage Li-ion Rechargeable Battery haphazardly in a box or drawer where they may short-circuit each other or be short-circuited by other metal objects.

Keep out of reach of children.

The Li-ion Rechargeable Battery with a Watt-hour rating not exceeding 100Wh or the cell with a Watt-hour rating in not exceeding of 20Wh, The lithium ion batteries according to Section II/Section IB of PACKING INSTRUCTION 965, or Section II of PACKING INSTRUCTION 966~967 of the 2017 Dangerous Goods regulations 58th Edition may be transported.
