

And recommended at  $15^{\circ}C \sim +25^{\circ}C$  for long period storage.

Please activate the battery once every 3 months according to the following method: Charge at 1.0C to 4.2

V, rest 10 min, then discharge with 1.0C to 3.0V/cell, rest 10 min, then charge at 1.0C to 3.85V.

The capacity recovery rate in the delivery state (50% capacity of fully charged) after storage is assumed to be 80% or more.

The voltage for a long time storage shall be3.7V~4.2V range.

Do not storage Lithium-ion Battery haphazardly in a box or drawer where they may short-circuit each other or be short-circuited by other metal objects.

Keep out of reach of children.

Do not expose Lithium Ion Battery to heat or fire. Avoid storage in direct sunlight.
