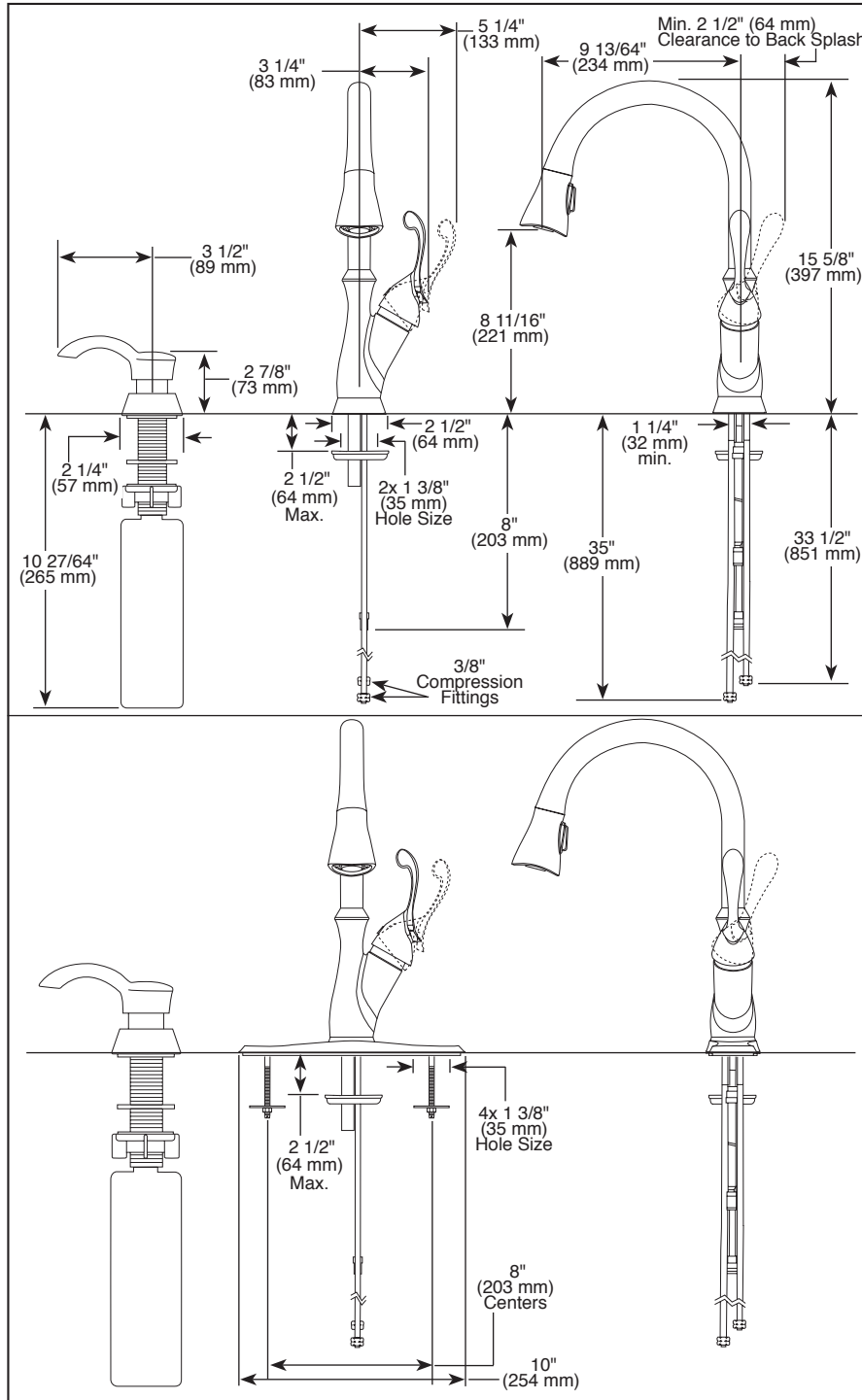

- Centermount or 8" (203 mm) centers with 10" (254 mm) escutcheon.
- $15\frac{5}{8}"$ (397 mm) high, $9\frac{13}{64}"$ (234 mm) long, spout swings 360° .
- Lever handle. Control mechanism is the diamond embedded ceramic disc cartridge.
- Control shall return to neutral position when faucet is turned off.
- Touch-Clean® 2 function (stream/spray) sprayhead.
- Quick Snap® connect hoses.
- Magnetic docking system secures sprayer to spout.
- Pull-down wand operates in an aerated or spray mode via an ergonomic toggle diverter.
