## WHERE TO USE

For uncoated and unsealed, properly prepared Interior or Exterior Patios, Pavers, Driveways\*, Walkways, Garage Floors\*, Pool Decks\*\* and other concrete floors. \* The composition of concrete varies; therefore, the lack of proper surface preparation and/or over application can lead to automobile tires lifting the product from the surface. \*\*Light and pastel colored concrete stains should be used over pool deck surfaces. DARK COLOURS RETAIN HEAT.

### **PREPARATION<sup>+</sup>**

(Proper surface preparation is required.) All surfaces must be clean, sound, dry and free of any dirt, oil and grease. New concrete must cure for a minimum of 30 days. Remove old coating or sealer, if present, using a product such as BEHR PREMIUM® No. 992 Concrete & Masonry Paint Stripper. Clean and etch surface using a product such as BEHR PREMIUM No. 991 Concrete & Masonry Cleaner & Etcher to achieve a textured profile similar to 150 grit sandpaper. Test: Sprinkle a few drops of water onto the surface. If water is quickly absorbed, the surface is ready. If not absorbed, re-etch. For areas subject to automotive traffic, apply a product such as BEHR PREMIUM No. 880 Concrete & Masonry Bonding Primer to increase adhesion of topcoat to the surface. Follow all label instructions.

### APPLICATION

Do not thin. Intermix cans of same products to ensure colour uniformity. STIR thoroughly before and during application. Use product when temperature is between  $50 - 90^{\circ}$  F (10 -  $32^{\circ}$  C). Do not apply in direct sunlight. Apply to dry concrete. Do not apply if rain or heavy dew is expected within 24 hours. Apply stain in small concrete sections approximately 4' by 4' (1.2 m x 1.2 m).

Apply with a high quality pump sprayer at a fine spray setting using a circular motion. *Optional: If a more even, uniform appearance is desired, immediately back roll after spraying with a 10 mm nap roller or pad applicator.* Spread rate will vary depending on the porosity and texture of the surface. Allow first coat to dry before deciding if a second coat is necessary. An additional coat will provide a darker and more uniform colour. Horizontal surfaces may be subject to premature wear. Periodic touch-ups may be necessary.

### **OPTIONAL TOPCOAT**

For added protection, use a product such as BEHR PREMIUM No. 985 Wet-Look Sealer for a high-gloss finish or a product such as BEHR PREMIUM No. 986 Low-Lustre Sealer for a low-gloss finish. Allow stain at least 4 hours to dry before topcoating. **NOTE:** Do not use Wet-Look Sealer or Low Lustre Sealer as a topcoat around pool decks or other areas subject to constant moisture. Follow all label instructions.

### **DRY TIME**

Longer dry time required in cooler temperatures and in higher humidity. Surfaces may be subjected to light foot traffic after 24 hours. Allow 72 hours before subjecting surface to heavy foot traffic, repositioning furniture or automotive traffic. Park tires on corrugated cardboard for 7 days after applying stain. After 30 days, clean as needed with a mild, non-abrasive liquid detergent.

#### CLEAN UP

Use soap and water. Properly dispose of all soiled rags and protect unused product from freezing. To recycle or properly dispose of product in your community, contact your household refuse collection service.
