If the Lithium-ion Battery is subject to storage for such a long term as more than 3 months, it is recommended to recharge the Lithium-ion Polymer Battery periodically. 3 months:  $-10^{\circ}C \rightarrow +40^{\circ}C$ , 45 to 85% RH And recommended at  $0^{\circ}C \rightarrow +35^{\circ}C$  for long period storage. The capacity recovery rate in the delivery state (50% capacity of fully charged) after storage is assumed to be 80% or more. The voltage for a long time storage shall be  $3.7V \rightarrow 4.2V$  range. Do not storage Lithium-ion Battery haphazardly in a box or drawer where they may short-circuit each other or be short-circuited by other metal objects. Keep out of reach of children. Do not store together with oxidizing and acidic materials. Keep ignition sources away- Do not smoke. Store in cool, dry and well-ventilated place.


