





To give you an overview of the Dining Chair parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.




Open the carton and place all the parts onto a clean, non-marring surface.

- 1.1 Insert the Dowel on the Backrest(D) into the mounting position of the Left Armrest(A).
- 1.2 Atach Backrest(D) to Left Armrest(A) using Bolts(1) and Washers(2) with Allen Key(3) as shown in the picture.

Do not fully tighten the Bolts.


Occasionally some of the PE Wicker shifts and covers the mounting positions preventing easy assembly. The PE Wicker should never be cut, but moved away from the mounting positions.

Step 2



- 2.1 Align Seat(C) with Left Armrest(A) and Backrest(D).
- 2.2 Attach Seat(C) to Left Armrest(A) and Backrest(D) using Bolts(\bigcirc) and Washers(\bigcirc) with Allen Key(\bigcirc) as pictured.

Do not fully tighten the Bolts.



Align Right Armrest(B) to Backrest(D) and Seat(C).

- 3.1 Insert the Dowel on the Backrest(D) into the mounting position of the Right Armrest(B).
- 3.2 Attach Right Armrest(B) to Backrest(D) and Seat(C) using Bolts(1) and Washers(2) with Allen Key(3) as shown in the picture.

Stand the Chair up.

Exert pressure floorwards, onto the Chair with both your hands.

This pressure will help the Chair reach full alignments status.


Check for wobbles on a LEVEL surface.

If no wobbles are found proceed to tighten the Bolts and Screws in a sequential manner, until evenly secured.

When tightening the Bolts and Screws sequentially.

DO NOT tighten any Bolt or Screw fully and then move on towards the next one. If there are still wobbles, loosen the Bolts and Screws and excute the same above process.

If the Chair is not stable it could lead to damage to the product.



Put the Seat Cushion(E) on the Chair.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.



This Table has multiple parts and may require up to some 30 minutes to assemble. To give you an overview of the Table parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.




Open the carton and place all the parts on a clean, non-marring surface.

Turn table top upside down,then attach Leg Panels (B) to the Table Top(A) using Bolt(\Im) and Washer(\Im) with Allen Key(\Im) as shown in the picture above.

Repeat this process with the other Leg Panel (B)


Do not fully tighten the Bolts.



Attach Leg Support Panel(C) between Leg Panels(B) using Bolt(3) and Washer(2) with Allen Key(1) as shown in the picture above.

Repeat the same process to affix the another Leg Support Panel(C)

Do not fully tighten the bolts.



Place the table on a LEVEL SURFACE to check for wobbles.

If it wobbles, with 2 to 3 adult partners, lift the table to some 20cm to 30cm height from the ground. Keep your feet and toes well away from the drop zone.

Drop the table freely and vertically with the four legs, hitting the ground, all at the same time.

This Drop Test will help to ensure that all the bolts and gaps to all reach full alignment status.

Test again for evenness on a LEVEL SURFACE.

If no wobbles found, with assistance from 2 to 3 adult partners, slowly and steadily, turn the table upside down.

Then, proceed to tighten all bolts in a sequential manner.


CAUTION: When tightening these bolts, tighten sequentially.

DO NOT tighten any screw fully and then towards the next one.

This would cause the frame to warp.

If there is still wobbles, loosen the bolts and execute this same drop tests.

What is Proposition 65?

Proposition 65 is a California law that requires warning labels on products that may contain one of more than 800-plus chemicals or ingredients that the California Office of Environmental Health Hazard Assessment (OEHHA) has deemed to cause cancer or other reproductive toxicity. Chemicals and elements on this list include wood dust, brass, and other everyday substances, which can be found in very common household items, such as: lamps, tableware, jewelry, crystal glasses, electric cords, beauty products, automobiles, and furniture.

Why Did I Find a Proposition 65 Warning on My Home Goods Product?

We include Proposition 65 warnings on all of our products because there is always a chance that one of the 800-plus common chemicals and ingredients listed under this law could potentially be on our furniture or packing materials. We risk large fines under this law, if we don't include this warning.

Should I worry?

We realize you may be worried finding this warning on our products, but we want to reassure you that the hazardous exposure limits for any of these chemicals have never been found on furniture products that we've shipped to our customers. Additionally, this warning label is very common and can be found on almost every piece of furniture sold in the state of California.

Just How Common Are Proposition 65 Warnings?
