4. First Aid Measures

General Advice

Protective equipment and precautions for firefighters

Avoid deep discharge. Do not short-circuit batteries use recommended charging time and current.

The transport vehicle should prevent exposure, rain and high temperature. For stopovers, the vehicle should be away from fire and heat sources. When transported by sea, the assemble place should keep away from bedroom and kitchen, and isolated from the engine room, Power and fire sources.
