# **SECTION 3: HAZARDS IDENTIFICATION**

## 3.1 EMERGENCY OVERVIEW

**Specific Physical Form:** Aerosol

### 3.2 POTENTIAL HEALTH EFFECTS

#### **Eye Contact:**

Mild Eye Irritation: Signs/symptoms may include redness, pain, and tearing.

#### **Skin Contact:**

Moderate Skin Irritation: Signs/symptoms may include localized redness, swelling, itching, and dryness.

### **Inhalation:**

Intentional concentration and inhalation may be harmful or fatal.

Respiratory Tract Irritation: Signs/symptoms may include cough, sneezing, nasal discharge, headache, hoarseness, and nose and throat pain.

#### **Ingestion:**

# **SECTION 4: FIRST AID MEASURES**

### 4.1 FIRST AID PROCEDURES

The following first aid recommendations are based on an assumption that appropriate personal and industrial hygiene practices are followed.

**Eye Contact:** Flush eyes with large amounts of water. If signs/symptoms persist, get medical attention.

# SECTION 6: ACCIDENTAL RELEASE MEASURES

# 6.1. Personal precautions, protective equipment and emergency procedures

Refer to other sections of this MSDS for information regarding physical and health hazards, respiratory protection, ventilation and personal protective equipment. Evacuate unprotected and untrained personnel from the hazard area. The spill should be cleaned up by qualified personnel. Ventilate the area. WARNING! A motor could be an ignition source and could cause flammable gases or vapors in the spill area to burn or explode. If it can be done safely, place the leaking containers in an exhaust hood or well- ventilated area. WARNING! #### **6.2.** Environmental precautions

Contain spill, using absorbent if necessary. Collect spilled material with non-sparking tools. Clean up residue. Place depressurized cans and clean up wastes in a metal container approved for transportation. Seal the container.

# **SECTION 7: HANDLING AND STORAGE**

### 7.1 HANDLING

Ground containers securely when transferring contents. Wear low static or properly grounded shoes. Do not spray near flames or sources of ignition. Aerosol container contains flammable gas under pressure. Do not pierce or burn container, even after use. No smoking while handling this material. Keep away from heat, sparks, open flame, pilot lights and other sources of ignition. Avoid breathing of vapors, mists or spray. Avoid skin contact. Avoid eye contact with vapors, mists, or spray. Avoid contact with oxidizing agents.

# 7.2 STORAGE

Store away from heat. Store out of direct sunlight. Store away from oxidizing agents. Do not store containers on their sides.
